PDQ's MR Series Grade 1 Mortise Locks, XGT and GT Series Grade 1 Cylindrical Locks, and 6200 Series Grade 1 Rim and Surface Vertical Rod Exit Devices are Florida Building Code compliant and approved for use in the HVHZ.

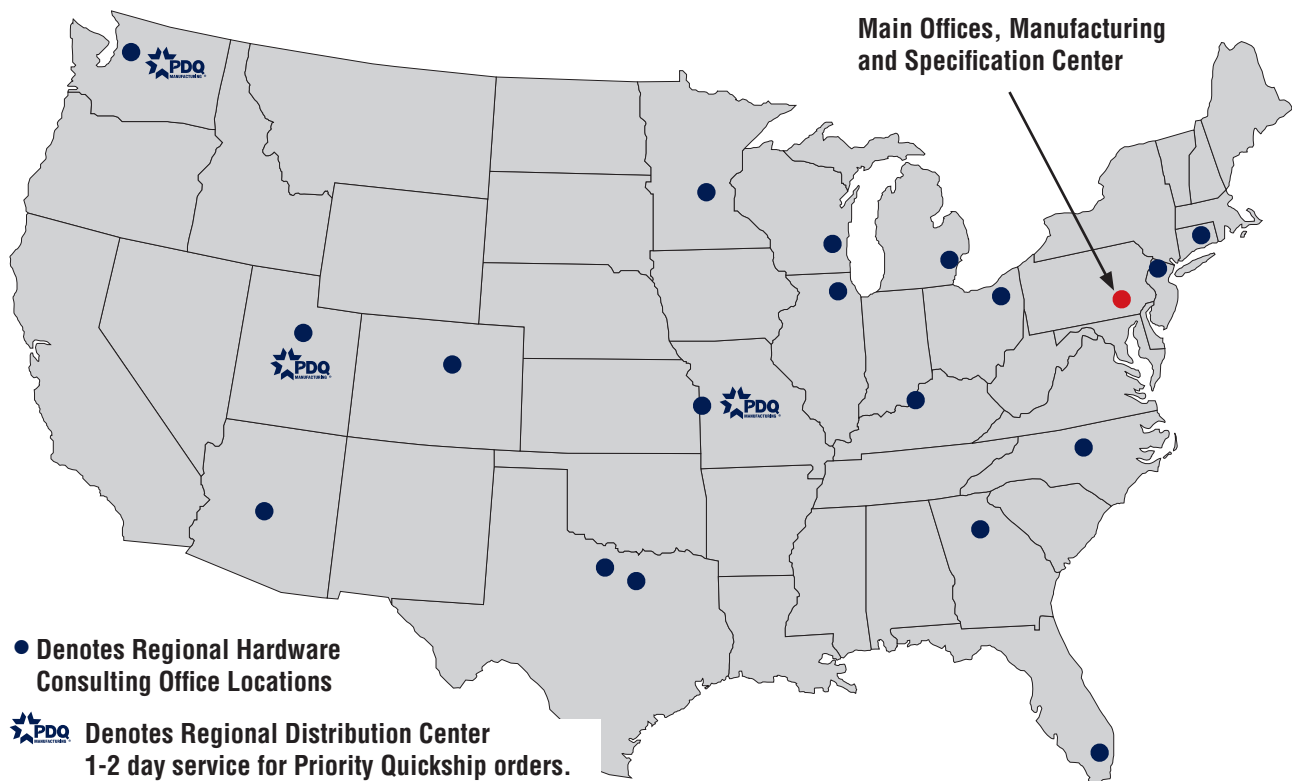
